The historic Hakone Estate and Gardens served as a private residence for the first 50 years of its existence, and for the last 52 years it has been a crown jewel as one of Saratoga's parks. The City and Foundation would like to ensure that future generations will be able to enjoy this cultural beauty.

Hakone has become a destination for visitors from all over the globe; Hakone also serves as an event venue for private family events and business meetings and retreats. But most importantly, Hakone is a place for you to experience a wide variety of Japanese and Asian culture including: meditation, tai chi, karate, Urasenke tea ceremony, Omotesenke tea ceremony, Chinese Lunar New Year Festival, and the Hakone Matsuri.
